#### Explanation of Responses:

1. This option vested as to 20% immediately on the grant date, October 2, 2000, and an additional 20% on each of the next four anniversaries of the grant date.

2. On July 2, 2009, pursuant to the issuer's option exchange program, the issuer cancelled an option granted to the reporting person on October 2, 200 and issued a replacement option to the reporting person for 8,000 shares, having an exercise price equal to the closing price of the underlying Class A common stock on the grant date, as reported by the Nasdaq Global Select Market.

3. 20% of the shares subject to this option vested on July 2, 2009, and an additional 20% of the shares subject to this option will vest on each of the first four anniversaries of July 2, 2009, such that this option will be fully vested on July 2, 2013, provided that vesting is conditioned on the reporting person's continued active service to the Company or one of its subsidiaries through each applicable vesting date.
